Handling

Open the bucket by removing the lid and pull the first wipe from the centre of the roll through the central opening in the lid. Close the lid again. Pull the wipe from the top of the bucket through the lid and take wipes as needed.

Individual wipes can be removed via perforation. Use the rough side of the wipe for heavy soiling and the soft side for delicate surfaces. Rub the wipe over the soiled area until clean. Applying slight pressure will speed up the process.

We recommend testing on an inconspicuous area before use to check for material compatibility.
